



## **Task Force Members' Biographies**

**Co-Chair Shirley Lewis** is the Assistant Vice President for Old Republic Title Company, Commercial Department, Santa Clara County. She is a native of San Jose and a graduate of Notre Dame High School and San Jose State University. She served as a San Jose City Councilmember for twelve years from 1981 through 1992, including two years as Vice Mayor and four years as Vice Chair of the Redevelopment Agency; six and half years as the Executive Director of the San Jose Symphony and the San Jose Youth Symphony; and three years as the Vice President of Development for the Mobedshahi Hotel Group where she oversaw renovation and development projects for two and half years. Besides her active career, Shirley has six children, seven grandchildren, one great grandchild and is involved in many community organizations including the Rotary Club of San Jose, the Friends of the Guadalupe Park & Gardens, First Community Housing and the COMPAC Board of the Chamber of Commerce.

**Co-Chair, Councilmember Sam T. Liccardo** represents San Jose's downtown district, District Three, on the San Jose City Council. Prior to winning election to City Council in November of 2006, Sam served as a prosecutor of sexual assault and child exploitation crimes in the Santa Clara County District Attorney's Office. He previously worked as a federal prosecutor and at private law firms. Sam's previous work in the community included tutoring homeless children, serving on the boards of several affordable housing organizations, and advocating for a successful countywide transit ballot measure in 2000. After graduating from Bellarmine College Prep in San Jose, Sam attended Georgetown University studying government and economics and graduated magna cum laude in 1991. Subsequently, he enrolled at Harvard Law School and Harvard's Kennedy School of Government. In addition to his role on the City Council, Sam also serves on Envision San Jose 2040 General Plan Update Task Force (Co-Chair); Transportation and Environment Committee (Vice-Chair); Community and Economic Development Committee (Member); Association of Bay Area Governments (Executive Board member); Downtown Working Group (Member); Santa Clara County Cities Association (Board member); Santa Clara Valley Transportation Authority (Board member); Valley Transit Authority Policy Advisory Board for Downtown/East Valley Corridor (Member); and Downtown Parking Board (Liaison).

**Vice Chair David Pandori** is a former member of the San Jose City Council who represented the downtown area from 1991 through 1998. He has a degree in Environmental Studies from San Jose State University and a Masters Degree in City Planning from UC Berkeley. He has been a Deputy District Attorney since leaving the City Council and prosecutes gang members and career criminals.

**Jacquelyn Adams** has lived in San Jose for 30 years, of which 27 years have been as a homeowner and active community member in District 2. She is married and the proud mother of two terrific sons. She is currently employed as a Program Manager with the Santa Clara Valley Transportation Authority. She is also serving her 16 plus years as a member of the Oak Grove School District Board of Trustees. She is a past member of the Diversity Committee and District 2 Advisory Committee, and was an employee for 22 years with the Santa Clara County Public Health Department. She has a B.A. degree in Social Science and a Masters degree in Public Health.

**Teresa Alvarado** is the Executive Director of the Hispanic Foundation of Silicon Valley, which cultivates philanthropic leadership in the Hispanic community. She previously worked in both Public Affairs and Charitable Contributions for Pacific Gas and Electric Company. Teresa, a San José native, is active in community service. She currently serves on the boards of CompassPoint Nonprofit Services and SJECCD Foundation and advisory boards of the San Jose Education Foundation, Hispanic-Net, Latina Coalition of Silicon Valley and Emerge: Women Leaders for a Democratic Future. She is a member of Class XIX of the American Leadership Forum Silicon Valley. Teresa holds a M.S. degree in Civil and Environmental Engineering from Tufts University, a B.S. degree in Environmental Technology & Management from San Jose State University, and a Minor degree in Technical Writing from San Jose State University. She is married to Jess Moreles, has two stepsons and one dog. Teresa loves to walk, run, hike and backpack and is an avid film, music and performing arts fan.

**Shiloh Ballard** is the Director of Housing and Community Development for the Silicon Valley Leadership Group. She grew up in a rent controlled apartment in westernmost San Jose, where she benefited from excellent public schools in addition to a parenting philosophy by her mother that relied upon the notion of keeping a child out of trouble by keeping the child completely booked—Girl Scouts, choir, theatre, dance classes, soccer, flute lessons, church youth group and lots of Nancy Drew mysteries.
