The procedure for this hearing is as follows:

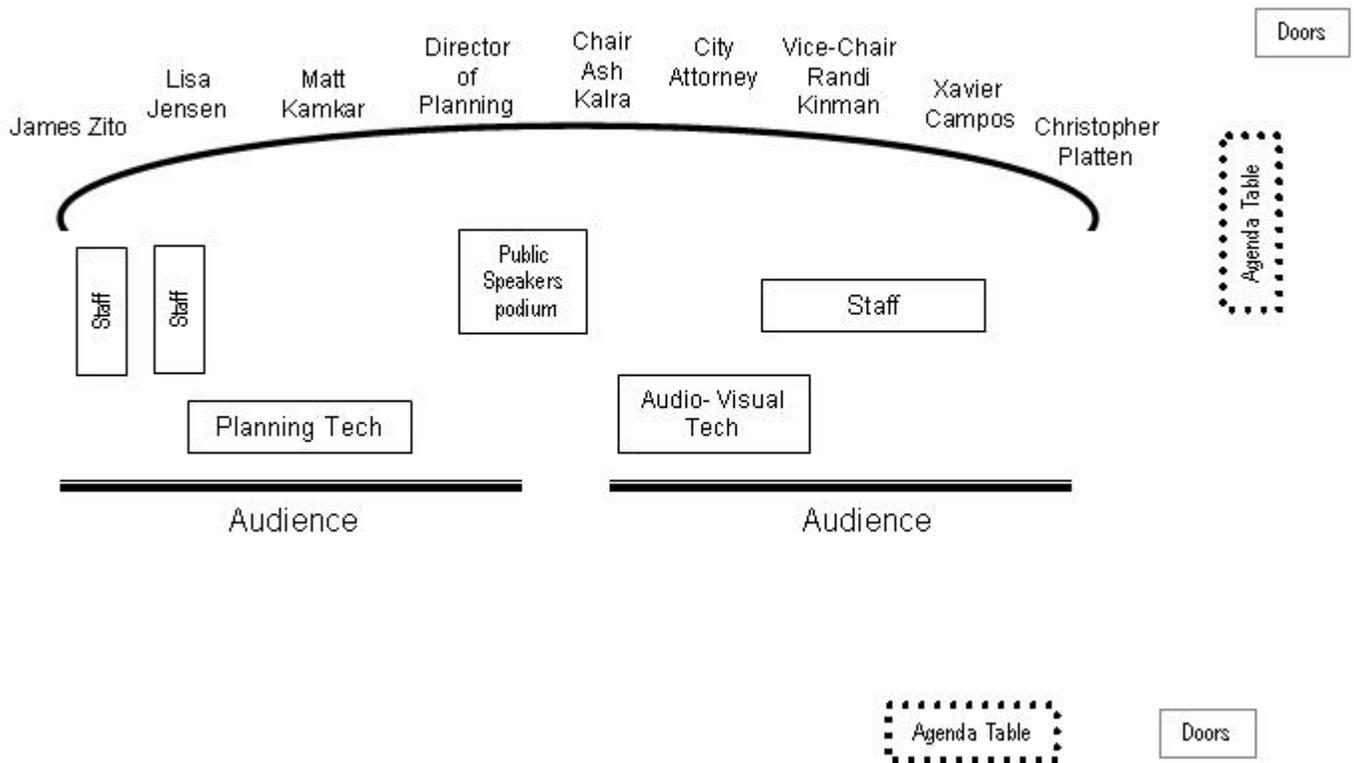
- After the staff report, applicants and appellants may make a 5-minute presentation.
- The chair will call out names on the submitted speaker cards in the order received.
- As your name is called, line up in front of the microphone at the front of the Chamber. Each speaker will have two minutes.
- After the public testimony, the applicant and appellant may make closing remarks for an additional five minutes.
- Planning Commissioners may ask questions of the speakers. These questions will not reduce the speaker's time allowance.
- The public hearing will then be closed and the Planning Commission will take action on the item. The Planning Commission may request staff to respond to the public testimony, ask staff questions, and discuss the item.

If you challenge these land use decisions in court, you may be limited to raising only those issues you or someone else raised at this public hearing or in written correspondence delivered to the City at, or prior to, the public hearing.

The Planning Commission's action on rezoning, prezonings, General Plan Amendments and Code Amendments is advisory only to the City Council. The City Council will hold public hearings on these items. Section 20.120.400 of the Municipal Code provides the procedures for legal protests to the City Council on rezonings and prezonings. The Planning Commission's action on Conditional Use Permit's is appealable to the City Council in accordance with Section 20.100.220 of the Municipal Code. Agendas and a binder of all staff reports have been placed on the table near the door for your convenience.

The Planning Commission is a seven member body, appointed by the City Council, which makes recommendations to the City Council regarding the adoption, amendment, or repeal of general or specific plans, and regulation of the future physical land use development, redevelopment, rehabilitation or renewal of the City, including its Capital Improvement Programs. The recommendations to the Council regarding land use development regulations include, but are not limited to, zoning and subdivision recommendations. The Commission may make the ultimate decision on Conditional Use Permits, and acts as an appellate body for those persons dissatisfied with the Planning Director's decisions on land use and development matters. The Commission certifies the adequacy of Environmental Impact Reports.

Conditional Use Permit to allow a 3,700 square foot indoor recreation use in an existing 16,400 square foot building on a 1.14 gross acre site in the IP Industrial Park Zoning District, located on the northerly side of Martinvale Lane, approximately 500 feet easterly of Santa Teresa Boulevard (181 MARTINVALLE LN)(Randy and Lisa Hooks, owners). Council District: 2. SNI: None. CEQA: Exempt.

APPROVED (6-0-1; CAMPOS ABSENT)

- b. **CPA05-015-01.** Conditional Use Permit Amendment to allow for a performing circus with no animals for the period from December 2007 to March 2008 on a 4.85 gross acres site in the R-1-8 Single-Family Residence Zoning District, located on the west side of North San Pedro Street between West Taylor Street and West Mission Street. (City of San Jose, Owner; Cirque du Soleil, Rene Pepin, Applicant). Council District: 3. SNI: None. CEQA: Exempt.

APPROVED (6-0-1; CAMPOS ABSENT)

Pulled from consent and heard at a public hearing. Two property owners spoke and expressed their concern with patrons of the Cirque parking and blocking access to their driveway, as well as the amount of litter they experience on their property with the last event. Additionally, they experienced a number of residents traversing their corner property on their way through the neighborhood. The Commission discussed their concerns with other City Staff present from DOT, Police, and the Office of Cultural Affairs. All committed to continuing to work with the property owners and the neighborhood to further refine a parking management plan, refuse management plan, and to ensure access to point people before, during, and after the events to address issues as they occur. The Commission approved the Conditional Use Permit with additional conditions related to continuing to work with the neighborhood to address the above discussed issue.

- b. Distribution of Draft Environmental Impact Report for the Zanker Materials Recycling Facility Planned Development Zoning (File No. PDC06-120). The project would allow construction of a 200,000 square foot Materials Recovery Facility (MRF) building and to relocate existing material recycling activities to the MRF building; increase in the peak daily tonnage received and processed from 1,250 tons to 5,000 tons; allow the acceptance, transfer off-site and the possible future screening and sorting of green/yard waste and municipal solid waste (MSW) including food waste inside the MRF building; relocate and expand the scale house facilities to accommodate the proposed increased daily tonnage; allow site operations to occur 24 hours per day, 7 days per week; use the surface of the existing landfill (after landfill closure) for ancillary operations such as employee parking, truck parking, temporary materials storage, and/or a retail soil/materials yard and install new outdoor lighting at the facility. Distributed October 2, 2007. Scheduled for December 5, 2007 Planning Commission Hearing.
- c. Distribution of Draft Environmental Impact Report for the Coleman Avenue/Autumn Street Improvement Project (File No. PP06-166). The objective of the project is to provide additional roadway capacity in the Coleman-Autumn corridor in order to adequately accommodate projected traffic demand. The proposed improvements are a key component of the *Downtown San José Strategy 2000 Plan*, a long-term plan for development in the greater downtown area that was approved by the San José City Council in June 2005. CITY OF SAN JOSÉ CODE OF CONDUCT FOR PUBLIC MEETINGS IN THE COUNCIL CHAMBERS AND COMMITTEE ROOMS

The Code of Conduct is intended to promote open meetings that welcome debate of public policy issues being discussed by the City Council, Redevelopment Agency Board, their Committees, and City Boards and Commissions in an atmosphere of fairness, courtesy, and respect for differing points of view.

1. Public Meeting Decorum:

- a) Persons in the audience will refrain from behavior which will disrupt the public meeting. This will include making loud noises, clapping, shouting, booing, hissing or engaging in any other activity in a manner that disturbs, disrupts or impedes the orderly conduct of the meeting.
- b) Persons in the audience will refrain from creating, provoking or participating in any type of disturbance involving unwelcome physical contact.
- c) Persons in the audience will refrain from using cellular phones and/or pagers while the meeting is in session.
- d) Appropriate attire, including shoes and shirts are required in the Council Chambers and Committee Rooms at all times.
- e) Persons in the audience will not place their feet on the seats in front of them.
- f) No food, drink (other than bottled water with a cap), or chewing gum will be allowed in the Council Chambers and Committee Rooms, except as otherwise pre-approved by City staff.
- g) All persons entering the Council Chambers and Committee Rooms, including their bags, purses, briefcases and similar belongings, may be subject to search for weapons and other dangerous materials.

2. Signs, Objects or Symbolic Material:

- a) Objects and symbolic materials, such as signs or banners, will be allowed in the Council Chambers and Committee Rooms, with the following restrictions:
 - No objects will be larger than 2 feet by 3 feet.
 - No sticks, posts, poles or other such items will be attached to the signs or other symbolic materials.
 - The items cannot create a building maintenance problem or a fire or safety hazard.
- b) Persons with objects and symbolic materials such as signs must remain seated when displaying them and must not raise the items above shoulder level, obstruct the view or passage of other attendees, or otherwise disturb the business of the meeting.
- c) Objects that are deemed a threat to persons at the meeting or the facility infrastructure are not allowed. City staff is authorized to remove items and/or individuals from the Council Chambers and Committee Rooms if a threat exists or is perceived to exist. Prohibited items include, but are not limited to: firearms (including replicas and antiques), toy guns, explosive material, and ammunition; knives and other edged weapons; illegal drugs and drug paraphernalia; laser pointers, scissors, razors, scalpels, box cutting knives, and other cutting tools; letter openers, corkscrews, can openers with points, knitting needles, and hooks; hairspray, pepper spray, and aerosol containers; tools; glass containers; and large backpacks and suitcases that contain items unrelated to the meeting.

**CITY OF SAN JOSÉ CODE OF CONDUCT FOR PUBLIC MEETINGS IN
THE COUNCIL CHAMBERS AND COMMITTEE ROOMS (CONT'D)**

3. Addressing the Council, Redevelopment Agency Board, Committee, Board or Commission:
- a) Persons wishing to speak on an agenda item or during open forum are requested to complete a speaker card and submit the card to the City Clerk or other administrative staff at the meeting.
 - b) Meeting attendees are usually given two (2) minutes to speak on any agenda item and/or during open forum; the time limit is in the discretion of the Chair of the meeting and may be limited when appropriate. Applicants and appellants in land use matters are usually given more time to speak.
 - c) Speakers should discuss topics related to City business on the agenda, unless they are speaking during open forum.
 - d) Speakers' comments should be addressed to the full body. Requests to engage the Mayor, Council Members, Board Members, Commissioners or Staff in conversation will not be honored. Abusive language is inappropriate.
 - e) Speakers will not bring to the podium any items other than a prepared written statement, writing materials, or objects that have been inspected by security staff.
 - f) If an individual wishes to submit written information, he or she may give it to the City Clerk or other administrative staff at the meeting.
 - g) Speakers and any other members of the public will not approach the dais at any time without prior consent from the Chair of the meeting.

Failure to comply with this Code of Conduct which will disturb, disrupt or impede the orderly conduct of the meeting may result in removal from the meeting and/or possible arrest.
